	<p>is large and has diverse representation. They have similar issues (e.g., Implied Consent). They have similar professions and a good rapport. Both task forces want to make a change. Differences include giving a teleconference number for their meetings. FL Model Language for impairment laws framework is in progress. Their Blood Draw Search Warrant is complete. They seem to be more pro-active rather than re-active. FL doesn't provide food or beverages at their meetings which are much longer (half days and/or full days). FL doesn't have a repository for crashes (TITAN). They need a system for DUI's as well. Non-profit programs are offered including counseling and supervision to get reduced jail time and license reinstatement quicker. There was suggested legislation on blood test alcohol exclusion. They provide Implied Consent cards and pads. FL has increased meeting durations and they have been meeting for longer than we have. Their website is strong and includes their Strategic Plan, agenda, and action items in progress. They go through their Strategic Plan at each meeting and review action items.</p> <p>c. Questions</p> <p>7. Updates from Membership</p> <p>a. Robert Seesholtz reported for Health that EMS software procurement is in progress. Opioid grant funding has been given for a Statistical Analyst.</p> <p>b. Leon Burns reported the green book interpretation differs widely and mentioned the DRE program protocol process.</p> <p>c. Jeana Hendrix, AOC Assistant General Counsel, filled in for Michelle Consiglio-Young. Jeana reported updates regarding the Electronic Monitoring Indigency Fund (formerly named the DUI Monitoring Fund). First, the AOC updated the Affidavit of Indigency pursuant to PC1046 adding information on who pays, fund payment, and types of devices. Second, there has been a discrepancy regarding the specific devices covered by the Fund, resulting in a request for an AG's Opinion by the State Treasurer. Out of caution due to questioning from the Comptroller, the Treasurer is distributing funds only for payment of interlock and other similar monitoring devices, not GPS devices. The AOC anticipates that the Treasurer will draft an explanation letter for distribution to all judges. The AOC is not the holder or auditor of funds. Claims are being held in abeyance. The AG released that opinion August 16.
